CLEAN OUT ANIMALS REGULARLY, WASH HURDLES AND AREA AROUND PENS DAILY. PROVIDE PLENTY OF HAND WASHING FACILITIES (HAND WASHING STATIONS AROUND FARM AS WELL AS TOILET BLOCK) SOAP RUNNING WATER HAND DRYING ALCOHOL WIPES. PUT UP PLENTY OF SIGNS TO REMIND PEOPLE TO WASH. ONLY ALLOW FOOD TO BE EATEN IN FOOD AREAS WHICH ARE ANIMAL FREE.</p>	<p>LOW</p>

CONTACT WITH ANIMALS	CHILDREN BEING BITTEN KICKED OR TRAMPLED	MEDIUM	WARN CHILDREN TO KEEP AWAY FROM ANIMALS THAT COULD BITE AND REMOVE ANIMALS THAT HAVE A HISTORY OF BITING. DO NOT ALLOW CHILDREN INTO ANIMAL ENCLOSURES (EXCEPTION OF MILKING THE COW WHEN ONLY ONE CHILD WILL BE ALLOWED IN AT A TIME UNDER SUPERVISION) KEEP ALL FENCES AND BARRIERS IN GOOD REPAIR.	LOW
LOOSE GATES HURDLES OR MACHINERY	FALLING ON A CHILD	HIGH	TELL CHILDREN NOT TO CLIMB.ALWAYS TIE LOOSE OBJECTS SECURLY	LOW

TRACTOR RIDE	FALLING OFF OR BEING RUN OVER	HIGH	FIT TRAILOR WITH SIDES TO COMPLY WITH HSE. MAKE CHILDREN SIT DOWN. USE TAIL LIFT FOR LOADING. START RIDE FROM AREA WHICH ONLY HAS PUBLIC ACCESS UNDER SUPERVISION. NEVER LEAVE UNSUPERVISED CHILDREN ON TRAILER GIVE SAFETY INSTRUCTIONS BEFORE STARTING RIDE..	LOW
WOODLAND WALK	SLIPPING OVER CATCHING FOOT IN RABBIT HOLE	MEDIUM	WARN OF RISK BEFORE ENTERING THE WOOD. DO NOT WALK DOWN STEEP BANK IN WET CONDITIONS. WEAR SUITABLE FOOTWEAR. LEAD THE WAY DO NOT ALLOW CHILDREN TO GO INFRONT OF GUIDE. SUPERVISE WELL MAKE REGULAR CHECKS OF WOOD AND REMOVE FALLEN BRANCHES ETC	LOW

PLAY AREA	FALLING FROM PLAY EQUIPMENT	HIGH	MAKE REGULAR CHECKS OF ALL EQUIPMENT. PUT SAFETY MATTING IN APPROPRIATE PLACES. LIMIT ACCESS IN WET CONDITIONS SUPERVISE CHILDREN AT ALL TIMES.	LOW
WOODEN WALKWAYS AROUND DUCK POND	SLIPPING WEN WET	HIGH	APPLY SAND TO MAKE SURFACE NON SLIP.	LOW
